


### Who We Are

Since 2011, Amici Curiae Friends of Court (AC) has offered free public legal education and legal form filling services across Metro Vancouver. In 2023, in response to the demand for our services, AC became a provincial service provider.



### Our Programming:

- **Public legal education** about filing for a divorce, human rights and other everyday law topics.
- **Weekly form filling workshops**, with expedited services for survivors of intimate partner violence, Indigenous clients, and those impacted by the Lapu Lapu festival incident.
- **Publishing materials** for everyday use in plain language and in several languages.
- **Appearance preparation services.**
- **Affidavit swearing services.**
- **Providing support person services** for self-litigants who are appearing before the Provincial Court of BC.

### Our Values

The ability to independently access the legal system is a challenge for ordinary British Columbians, and more so for individuals who belong to equity-deserving groups.

The majority of our clients belong to equity-deserving groups, particularly those who are Indigenous, Black, or racialized, identify as women or gender diverse, or are survivors of residential schools or intimate partner violence.

We continue to develop intentional programs that are responsive to our clients' unique and diverse lived experiences. Our work is rooted in equity, intersectionality, accessibility, and solidarity. Our staff are trained to provide culturally relevant and trauma-sensitive support in order to better serve our clients.

As part of its commitment to advancing access to legal services for Indigenous people, AC offers expedited legal services for individuals who self-identify as Indigenous. This practice aligns with AC's mandate to assist any Indigenous client even if they may not have an appointment.

## Investing in Competent and Caring Volunteers

AC has been supporting Indigenous clients to file class actions claims from the 60s Scoop, Indian Day School, and now, Indian Boarding Homes.

To provide this support with care and integrity, AC staff and volunteers received training in Vancouver and Kamloops. The training focused on two key areas: providing a clear understanding of the forms and documentation required; and equipping participants with trauma-sensitive interview techniques to ensure clients feel safe, respected, and supported.

The sessions were led by judges, Indigenous legal professionals, and academics, who generously shared their lived experiences of injustice, resilience, and hope. Their insights underscored the importance of culturally informed and compassionate legal support.

*"AC is an integral organization that ensures that the most vulnerable Indigenous claimants have timely and appropriate access to settlement funds. These funds require claimants to disclose extremely traumatic parts of their lives in overly complicated letters, applications, and processes that are difficult to navigate.
